

SCHOOL PARKING INFORMATION

Timed Parking

Where a traffic control device restricts parking to a number of minutes or hours, no Person shall Park a Vehicle in excess of that time span.

No Stopping Zone

Vehicles are not permitted to stop at any time, for any reason in this area.

No Parking Zone

No parking on any portion of roadway where parking is prohibited by a traffic control device.

School Bus Lane

Dependent on signage, no parking or stopping during specified times in this area.

<u>Fire Hydrant</u>

No stopping or parking within 5 meters of a fire hydrant curb point. This means that if you draw a line from the hydrant to the road curb/edge, you cannot stop or park within 5 meters on either side of that point.

Crosswalk

No stopping or parking within 5 meters of the crosswalk markings on the road on either side.

Stop/Yield Signs

No stopping or parking within 5 meters of a Stop/yield Sign.

Driveways

It is prohibited to stop or park within 1.5 meters of a private driveway.

Transit Zones

Stopping/parking is prohibited all day from a Transit Sign extending 20 meters back.

<u>U-Turns</u>

Are prohibited between intersections, at controlled intersections, and where prohibited by signs.

Improper Parallel Parking/Double Parking

Passenger side tires of your vehicle must be no more than 50cm from the curb/edge of the roadway. In addition, you cannot Stop/Park beside a vehicle that is stopped or parked properly in a permitted area (double park).

Sidewalks & Private Property

Stopping or parking on a sidewalk is prohibited. Do not park in a private driveway unless permitted to do so by the property owner/occupant.

Jaywalking

Pedestrians shall not cross a portion of a roadway that forms part of a school zone during the respective hours of operation unless that person crosses that portion of roadway within a crosswalk.

Corner at Intersection

No stopping/parking within at an intersection nearer than 5m to the projection of the corner property line immediately ahead or immediately to the rear, except when the vehicle is parked in a space where a traffic control device indicates parking is permitted.

Resident Parking Only

No stopping/parking on roadway where parking is restricted to residents only - must display city authorized placard.

Safety First

This information sheet has been compiled by St. Albert Municipal Enforcement in conjunction with the RCMP. The safety of the children is our first priority. These parking and traffic restrictions are intended to provide safe movement of vehicles and pedestrians within a school zone. Please help keep our children safe by parking legally and obeying the traffic control devices.

This information sheet is not law nor does it contain all parking or traffic related offences. This is intended to give general knowledge on some common parking and traffic offences/problems in the school zone area when picking-up, dropping off children or visiting the school. These offences are a combination of Municipal Bylaws and Provincial Traffic Laws. For more information on these laws please contact the Municipal Enforcement Dept at (780)418-6643.
